At Rosemelling the plot next to the Old chapel; there is dispute over boundaries. The Cornwall Councillor for Luxulyan has agreed, on current information, that this should be treated as an exception site.

Good news that building work has started at the railway site which first got permission bin 1996.

FP reported that the Parish Council had received a letter from a plant hire firm wishing to create a new site at the Old wireless station just off the A30. Has a site in Bugle but wishes to move to create a larger depot. The firm G.A.P. group is a nationwide firm.
